WAIVER, RELEASE AND INDEMNIFICATION

And I approve of my child entering and taking part in the Rusty Gromfest '10. I understand that this is an event for young surfers and I DECLARE that my abovementioned child is either trained or is sufficiently fit and able to compete and agree for and on behalf of myself and my child that:-

1. My child and I will comply with all the rules and regulations and event instructions of the organisers and directions of their duly authorised officials.

2. For and on behalf of my child, myself, my executors, administrators, next of kin, successors and assigns I HEREBY release, waive, and forever discharge and keep indemnified the organisers and sponsors of the Rusty Gromfest '10 including, without limitation, the State of New South Wales, Ballina Shire Council, Byron Bay Shire Council, New South Wales Police service, Surfing Australia Inc ("SAI") and its' State Surfing Associations, all volunteers, employees, agents and officials of the aforementioned or any one or more of them or their executors, administrators, heirs, next of kin, successors or assigns ("the releases") including any and all claims for damage caused by the negligence of any of them arising out of my child's participation in the events and its' related activities, together with any costs including attorney's fee that may be incurred as a result of any such claim whether valid or not, and indemnify and hold harmless the releases and each of them against any such claim that I or my child or any one or more of my executors, administrators, heirs, next of kin, successors and assigns may have or assert against and any costs including attorney's fees with respect thereof.

3. I hereby acknowledge that my child and I have sole responsibility for our personal possessions and equipment during the Rusty Gromfest '10 and its related activities.

4. I hereby indemnify and acknowledge that participation in the Rusty Gromfest '10 carries with it potential hazard.
